## 1. General

- 1.1. Tiare VOF owns and operates the [www.Tiare-Life.com](http://www.Tiare-Life.com) website (hereinafter referred to as: Tiare-Life). Tiare VOF is registered in the 's-Hertogenbosch trade register under number 65045157 and based in Sint-Michielsgestel at Zegenwerp 10, 5271 NC. - 1.2. Tiare-Life is an online retail concept intended for anyone who is looking for products that have been developed, designed and manufactured based on a unique authentic story where care for people and planet is fundamental. On Tiare-Life, you will find a range of online retailers that are, by Tiare's standards, worth visiting.
- 1.3. We are aware that you are placing your trust in us. And we therefore consider it our responsibility to protect your privacy. On this page, we will explain what data we collect when you visit our website, why we collect this data, and how we use this data to provide you with a better user experience. We want to be transparent about how we work.
- 1.4. This Statement applies to the Tiare website. Please be aware of the fact that Tiare is not responsible for other websites' and sources' privacy policy. By using this website, you are accepting the privacy policy of the online shops presented on our website.
- 1.5. Tiare respects the privacy of all users of its website, and sees to it that personal data submitted to us be treated confidentially.

Tiare checks the companies against its own definition of fair and responsible. Tiare therefore rejects any responsibility for information provided by third-party websites and sources cited.

  - check its clients' online shops for relevance and content.Despite these efforts, Tiare can never guarantee that its website or an online shop's website does not contain incorrect information.



### 3. Personal data

- 3.1. You are under no obligation to provide personal data. To gain access to certain parts of the Tiare-Life website, you are required to enter personal data. There are also parts of the website you can access without having to enter personal data. You may then not be able to access some parts.
- 3.2. By registering, you are submitting personal data to Tiare. After registering, it is your responsibility to keep your data up to date.
- 3.3. Your data will be stored in a secure database and not be disclosed to third parties, except when such third parties are contracted by Tiare to dispatch your prize to you.

### 4. How we use the data we collect

- 4.1. Use of our website  
When you register on our website, we will ask you to submit personal data. This data will be used exclusively to facilitate your use of our website. This data is stored on Tiare's proprietary servers or on third-party servers. We will not combine this data with other personal data that we possess.
- 4.2. Your personal and address details are used to
  - send you our newsletter. If you do not want to receive our newsletter, you can unsubscribe at any time;
  - be able to send you the prize for a prize contest you have won.
- 4.3. Communication  
We may retain any emails or other kinds of messages you send us. On some occasions, we may request you to enter personal data that is relevant in a specific situation. This will enable us to process your questions and meet your requests. This data is stored on Tiare's proprietary servers or on third-party servers. We will not combine this data with other personal data that we possess.
- 4.4. Cookies  
For research purposes, we collect data to gain insight into who uses our website, with a view to tailoring [www.Tiare-Life.com](http://www.Tiare-Life.com) to our users. We also collect data for commercial purposes to gain better insight into the products and services offered by the online shops in which you, as a user of our website, are interested. The website is sustained largely by selling advertising space to online shops for promotion of their products and services.  
This website uses so-called cookies (text files that are installed on your computer) to help the website analyse how users use the website. Website usage data generated by a cookie may be stored on Tiare's secure proprietary servers or on secure third-party servers. We use this information to track your usage of the website, to compile reports on website activity, and to offer other services relating to website activity and internet usage.
- 4.5. Purposes  
We do not collect or use information for purposes other than those specified in this Statement, unless we have received your prior consent for such other purposes.



- 4.6. Third parties  
With the exception of web applications we use for the online shops, the data will not be shared with third parties. This data will only be used for the purposes of the application in question and not be distributed otherwise.
- 4.7. Amendments  
This Statement is aligned with the use of and possibilities offered by this website. Possible adjustments and/or changes to this website may lead to amendments to this Statement. We therefore advise you to check this Statement regularly.
- 4.8. Personal data options  
We offer all users of our website the option to consult, edit, or delete any personal information that has been provided to us up to now.
- 4.9. Editing/unsubscribing from the newsletter service  
At the bottom of every email newsletter, you find the option to edit your personal details or unsubscribe from the newsletter.
- 4.10. Changing/deregistering from communications
